On or about January 9, 2018, plaintiff suffered severe and debilitating injuries as a result of Defendants' inability to properly operate a motor vehicle. Plaintiff was driving northbound on the entrance ramp from Woodway Dr. onto either Loop 610 or Interstate 10. Defendants, driving ahead of Plaintiff, abruptly and recklessly came to a complete stop colliding with one another on top of the entrance ramp causing a five-car pileup. Defendants driving immediately behind Plaintiff forcefully rammed into Plaintiff's vehicle causing Plaintiff to vigorously collide into the vehicles directly in front of him. As a result of Defendants' negligence, Plaintiff suffered severe and lasting physical injuries.
