On or about May 8, 2019, Plaintiffs were seriously injured as a result of an automobile crash that occurred in Ector County, Texas. On said date, Plaintiffs were driving southbound in the inside lane of the 1000 block of South County Road West (FM 1882), while Defendant Justin Johnson was driving northbound. Defendant Justin Johnson lost control of his vehicle and began to veer left into the oncoming traffic. Defendant Justin Johnson violently struck Plaintiffs' vehicle, causing their vehicle to spin, which caused serious and severe personal injuries to Plaintiffs, which warrants extensive medical care.
