**AMENDED ORDER FOR THE DIRECTION OF TDFPS CASES NOT ADDRESSED BY
PRIOR ORDER**

IT IS ORDERED that this order amends the *Order for the Direction of TDFPS Cases Not Addressed by Prior Order* filed on August 23, 2019.

IT IS ORDERED that, effective September 1, 2019, all cases filed by the Texas Department of Family and Protective Services ("TDFPS") shall no longer be directed to, or heard by, the C.P.S. Cluster Court.

IT IS ORDERED that, effective September 1, 2019, all cases filed by TDFPS on or after September 1, 2019, shall be filed and assigned 4/11ths to the 418th District Court and 7/11ths to County Court at Law #3.

IT IS FURTHER ORDERED that, effective September 1, 2019, the 418th District Court shall hear all cases requiring permanency hearings after a final order assigned to the 418th. IT IS FURTHER ORDERED that, effective September 1, 2019, County Court at Law #3 shall hear all cases requiring permanency hearings after a final order assigned to County Court at Law #3.

IT IS FURTHER ORDERED that all TDFPS cases pending in the 410th District Court and disposed cases requiring future permanency hearings in the 410th District Court shall be transferred to County Court at Law #3, including but not limited to those cases on Attachment A,

To County Court at Law #3: 10-11-12146.

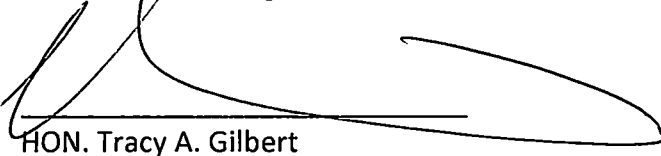

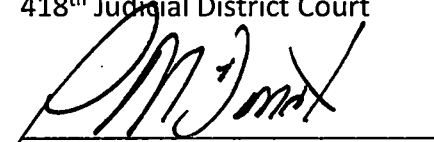

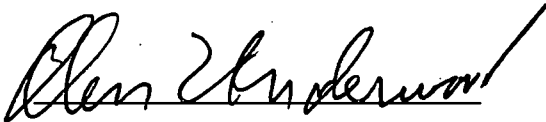
