STANDING ORDER OF CASE ASSIGNMENT RELATING TO POST JUDGMENT


Pursuant to Local Rules of the District Courts and the Local Rules of the County Courts at Law of Montgomery County, Texas this order accommodates for the transfer of closed civil cases originally assigned to courts no longer designated as civil courts upon the filing of a related garnishment case or a post judgment motion, application or petition on or after November 1, 2022.


Pursuant to the Texas Government Code, IT IS HEREBY ORDERED that, effective November 1, 2022 upon filing of a garnishment case the related closed civil case if filed in any court no longer receiving new civil filings shall be automatically and simultaneously upon filing of the garnishment case transferred to the court in which the garnishment case is to be filed pursuant to current standing orders for the allocation of newly filed civil cases.

IT IS FURTHER ORDERED that, effective November 1, 2022 upon the filing of any post judgment motion, petition or application in a case filed in any court no longer receiving new civil filings the clerk shall transfer said closed case to a civil court as if the case were newly filed pursuant to current standing orders for the allocation of newly filed civil cases.



It is ordered that the County and District Clerks shall process the transfer with no further order being necessary. Notwithstanding the foregoing, the above order does not apply to probate related civil matters in County Court at Law #2. Notwithstanding the foregoing, the above order does not apply when a request is made for copies from the file, unless the file was in County Court at Law #2 and it is on or after 10/1/2023.
