On the 13<sup>th</sup> day of August, 2015, a Board of Judges meeting was convened for the District and County Court at Law judges of Montgomery County, Texas. District Judges Case, Michalk, Gilbert and Seiler attended. District Judges Wood, Hamilton and Mayes were absent. County Court at Law Judges Watson, Laird and Turner attended. County Court at Law Judges McDonald and Stewart were absent. During this meeting, District Judge Gilbert made a motion, which was seconded by County Court at Law Judge Laird, that, due to computer programming difficulties, effective immediately the Order of Case Assignment (New Felony Cases) would be amended to order the Montgomery County District Clerk's office to assign all newly filed felony cases (capital and non-capital) as follows:

- 2/9 to the 9th District Court,
- 2/9 to the 221st District Court,
- 2/9 to the 359th District Court,
- 1/9 to the 410th District Court, and
- 2/9 to the 435th District Court.

After discussion, a vote was held on said motion. District Judges Michalk, Gilbert and Seiler, and County Court at Law Judges Watson, Laird and Turner voted in favor of the motion. District Judge Case voted against the motion. As such, the motion carried.

As such, pursuant to the Texas Government Code, IT IS HEREBY ORDERED that, effective immediately, the Montgomery County District Clerk's office shall assign all newly filed felony cases (capital and non-capital) as follows:

2/9 to the 9th District Court,

2/9 to the 221st District Court,


2/9 to the 359th District Court,

1/9 to the 410th District Court, and

2/9 to the 435th District Court.

IT IS FURTHER ORDERED that any and all prior orders regarding the assignment of new felony cases are hereby RESCINDED, and that this order shall become a Local Rule of Administration for the District Courts for Montgomery County, Texas, and shall amend any prior local rule of the District Courts for Montgomery County, Texas to the extent that they may conflict with any such prior local rule.
