## STANDING ORDER REGARDING FILES OF THE COMMUNITY SUPERVISION AND CORRECTIONS DEPARTMENT OF TARRANT COUNTY, TEXAS

Pursuant to an agreement and resolution of the District Courts Giving Preference to Criminal Cases, the Criminal District Courts, and the Statutory County Criminal Courts of Tarrant County, and recognizing that the files of the Community Supervision and Corrections Department (CSCD) are court files, the following is ORDERED regarding requests for information contained in a CSCD file:

- 1. Upon the written request of either the defendant's attorney or the attorney representing the state in a pending criminal case in Tarrant County, CSCD will provide a copy of the defendant's chronological-history information to the requesting party.
- 2. Before providing a copy of a defendant's chronological-history information to the defendant's attorney or to the attorney representing the state, CSCD may redact any information it deems necessary.
- 3. The defendant's attorney or the attorney representing the state may object to CSCD's redaction to the supervising court.
- 4. Any information provided under the terms of this order may be filed with the District Clerk or the County Clerk only if accompanied by an order of the supervising court placing the information under seal.
- 5. Upon receipt of a defendant's chronological-history information from CSCD, the attorney representing the state shall comply with Texas Code of Criminal Procedure Article 39.14.
- 6. The defendant's attorney may provide a copy of the defendant's CSCD chronological-history information to the attorney representing the state.

- 7. If either the defendant's attorney or the attorney representing the state receives a defendant's CSCD chronological-history information from opposing counsel, the information may not be further copied, shared, or otherwise disseminated.
- 8. Anything other than a defendant's chronological-history information contained within the CSCD file may be obtained only by order of the supervising court.
- 9. A third party requesting information contained within the defendant's CSCD file must present a written motion to the supervising court.
- 10. This order may be enforced by contempt.
- 11. A written request to CSCD for chronological-history information must contain the following acknowledgement:

"I am the attorney for  $\square$  the state  $\square$  the defendant in this case. I am requesting a copy of the defendant's chronological-history information from CSCD.

I affirm that I will not copy, share, or otherwise disseminate the defendant's chronological-history information, or any other information that I have obtained from CSCD, with anyone other than opposing counsel in the cause unless authorized by order of the supervising court.

I understand that this request is made under the Standing Order Regarding Files of the Community Supervision and Corrections Department of Tarrant County, Texas, and may be enforced by contempt."
