**STANDING ORDER OF THE COUNCIL OF JUDGES PORTRAIT DISPLAY POLICY**

ON THIS DATE, came on to be considered by the Local Administrative Judge of Fort Bend County, Texas, in her administrative authority and the presiding Judges of the District and County Courts of Fort Bend County, Texas (Council of Judges). The purpose of this Standing Order is to set policy regarding the portrait displays of former elected judges.

THEREFORE, IT IS ORDERED, ON AND AFTER MAY 30, 2023:

It will be the policy of the Fort Bend County Courts to display in the courtroom of the Court to which the Judge was elected:

Portraits of deceased former Fort Bend County Judges.

Portraits of living former Fort Bend County Judges who have retired from the practice of the law.

Portraits of living former Fort Bend County Judges who have not retired from the practice of law will be displayed in the courtroom, except when the former Fort Bend County Judge is a party to a contested matter being heard in the courtroom. On such occasions of contested matters, the former Fort Bend County Judge's portrait will be temporarily removed/covered from public viewing.
