STANDING ORDER REGARDING ELECTRONIC MONITORING DEVICES

The judges in the above-referenced courts in Travis County, Texas, enter the following order:

1. When individuals under the court-ordered supervision of the Travis County Community Justice Services (TCCJS) have been ordered to wear an electronic monitor and then are re-arrested in Travis County, TCCJS-Pretrial Services/Probation and the Travis County Sheriff's Office (TCSO) are ordered to remove electronic monitoring devices at the direction of TCCJS-Pretrial Services/Probation as needed while in custody.
2. This Order does not amend or suspend any original orders or bond conditions requiring supervised individuals to wear electronic monitoring devices when out of the physical custody of TCSO, and at the direction of TCCJS-Pretrial Services/Probation individuals will need to have electronic monitoring devices reinstalled if and when they are released from custody.
