



PERSONAL INFORMATION ABOUT JURORS


The District Court Judges Giving Preference to Criminal Cases, the Criminal District Court Judges, and the Statutory County Criminal Court Judges of Tarrant County who have signed this Standing Order hereby **ORDER** that in all cases, filed information collected by the court or by a prosecuting attorney during the jury-selection process about a person who serves as a juror, including the juror's home address, home telephone number, social-security number, driver's license number, and other personal information, shall be filed **UNDER SEAL** and shall not be publicly available or otherwise disclosed unless otherwise ordered. *See* Tex. Code Crim. Proc. Ann. art. 35.29(a); *see also* Tex. R. App. P. 9.10(g).

This standing order is subject to modification by court order.


