

STANDING ORDER REGARDING PRE-TRIAL SUPERVISION

The Criminal District Court Judges of Bexar County hereby issue the following Standing Order:

For individuals under Pre-Trial Supervision, the Pre-Trial Supervision officer shall permit attendance at the following verified events without requiring further permission or order from the Court, provided that such attendance does not violate any no-contact orders:

1. Attendance at a verified funeral of an immediate family member, as long as there are no other conflicts with respect to any other condition.
2. Attendance at a verified physician appointment.
3. Meeting with the attorney of record at the attorney's office.
4. Attendance at a hospital or emergency clinic for a verified medical emergency.

This order applies to all conditions of bond supervised by Pre-Trial Supervision, including GPS monitoring.




