Kiley as County Auditor of Williamson County, Texas for the two year term beginning January 1, 2025, at an annual salary of Two hundred two thousand seven hundred fifty seven dollars and twenty six cents (\$202,757.26) to be prescribed by law out of the General Fund of said Williamson County, Texas, and shall qualify as provided by Section 84 of the Texas Local Government Code.
