ADMINISTRATIVE ORDER REGARDING
THE APPOINTMENT OF CRIMINAL-LAW
MAGISTRATE TIMOTHY S. GILPIN TO SERVE
THE CRIMINAL COURTS OF TARRANT COUNTY, TEXAS

Whereas Texas Government Code section 54.651 provides for the appointment of criminal-law magistrates in Tarrant County;

Whereas the Tarrant County Commissioners Court consented and approved the position to be held by this criminal-law magistrate; and


Whereas at least two-thirds of the judges of the district courts of Tarrant County that give preference to criminal cases, the judges of the criminal district courts of Tarrant County; and the judges of the county criminal courts of Tarrant County have approved the appointment of

Timothy S. Gilpin


to exercise the powers and perform the duties authorized by Texas Government Code sections 54.656 and 54.658.


Therefore, it is ORDERED that effective December 16, 2024, Criminal-Law Magistrate Timothy S. Gilpin may act for all the judges described in Texas Government Code section 54.651(a) to the full extent permitted by law. All matters lawfully referable to criminal-law magistrates are ORDERED generally referred.


