468th District Court	Cases is which Thomas Wynne or Michael C. Wynne appear as counsel of record;
469th District Court	Cases where an attorney from the McCraw Law Group or McCraw Gantt, PLLC law firm appears as counsel of record;
	Cases in which Katherine McCraw appears as counsel of record;
	Cases where an attorney who rents office space from Mark McCraw appears as counsel of record;
471st District Court	Cases where an attorney from the McCraw Law Group or McCraw Gantt, PLLC law firm appears as counsel of record;
