Whereas the Tarrant County Commissioners Court consented and approved the position to be held by this criminal-law magistrate; and




to exercise the powers and perform the duties authorized by Texas Government Code sections 54.656 and 54.658.

All matters lawfully referable to criminal-law magistrates are ORDERED generally referred.
