**STANDING ORDER REGARDING RELEASE ON BAIL FOR PERSONS CHARGED WITH
FELONY OFFENSE COMMITTED WHILE ON BAIL FOR FELONY OFFENSE PURSUANT TO
ARTICLE 17.027 OF THE TEXAS CODE OF CRIMINAL PROCEDURE**

Pursuant to Texas Code of Criminal Procedure, Article 17.027(a)(1)(B), the Travis County District Courts with criminal jurisdiction hereby designate the following courts to conduct initial magistration in accordance with Article 15.17 of the Texas Code of Criminal Procedure and release on appropriate bail, if eligible, persons charged with a felony and who have a previous felony case pending in their courts:

1. Each District Court with criminal jurisdiction in Travis County, including the Travis County District Courts Criminal Law Associate Judges appointed under Chapter 54A of the Texas Government Code;
2. The Travis County Courts at Law; and
3. The Austin Municipal Court.

This order hereby supersedes and replaces the standing order in D-1-GN-61-121012, titled “Standing Order Regarding Texas Code of Criminal Procedure, Article 17.027 Release on Bail for Persons Charged with Felony Offense Committed While on Bail,” dated December 15, 2021.
