ADMINISTRATIVE ORDER
REGARDING THE REFERRAL OF MATTERS
TO THE CRIMINAL ASSOCIATE JUDGES WHO SERVE
THE CRIMINAL COURTS OF TARRANT COUNTY, TEXAS

Whereas the Judges in Tarrant County described in Government Code Section 54A.001 (the Judges) have appointed Criminal Associate Judges Wendy Cooper, Kacey Fickes, Timothy S. Gilpin, Brooke E. Panuthos, Terri Pearce, and James D. Rodgers to perform the duties authorized by Government Code Chapter 54A, Subchapter A, as set out in their respective appointment orders; and whereas the Judges occasionally appoint additional, temporary Criminal Associate Judges to perform those same duties:

It is hereby ORDERED that the appointed Criminal Associate Judges are authorized to act on behalf of the Judges who sign this administrative order to the full extent permitted by law. It is further ORDERED that all matters lawfully referable are generally referred to the Criminal Associate Judges by the Judges who sign this administrative order.




