STANDING ORDER ON THE MASTER CALENDAR

PREAMBLE

In accordance with the rules promulgated by the Texas Supreme Court in Misc. Dkt. No. 26-9019, and as authorized by the Texas Constitution, the Texas Government Code, and other applicable statutes, the judges of the undersigned Travis County Civil and Family District Courts issue this Standing Order for all cases not retained under Local Rule 2.6 or 10.2.

Timely access to the judicial system is an essential component of justice. The Master Calendar managed by the Travis County Court Administration Office allows for the most expeditious and efficient use of judicial resources to reach the greatest number of hearings and litigants as quickly as possible, while still ensuring each judge is responsible for every case filed in their court. This Standing Order must be read in conjunction with the Travis County District Courts' Standing Order on Motions for Summary Judgment.

TRAVIS COUNTY MASTER DISTRICT COURT CALENDAR

The below-signed courts hereby order that, for all existing cases and all newly filed cases that are not retained by the responsible judge pursuant to Local Rule 2.6 or 10.2, the following provisions shall be followed.

1. The Court Administrator and their appropriate designees shall assign and set hearings and trials on the Master Calendar for the Travis County Civil and Family District Courts.
2. For cases retained pursuant to Local Rule 2.6 or 10.2, parties and attorneys shall follow all directions from the responsible judge.

Courts who are non-signatories to this Standing Order have chosen not to participate in the Master Calendar and all cases filed in those courts are retained exclusively by the responsible judge under Local Rule 2.6.

This Standing Order is effective as of July 1st, 2026.
