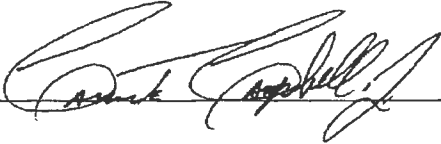

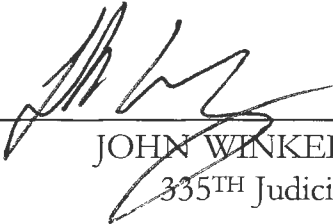

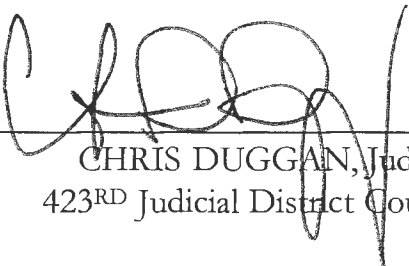
1. A party may move for a summary judgment on any claim or defense by filing a motion.
2. **The motion must be titled as follows:**
 - a. Traditional Motion for Summary Judgment;
 - b. No-Evidence Motion for Summary Judgment;
 - c. Combined Motion for Traditional and No-Evidence Summary Judgment;
 - d. Traditional Motion for Summary Judgment---Oral Hearing Requested;
 - e. No-Evidence Motion for Summary Judgment---Oral Hearing Requested; or,
 - f. Combined Motion for Traditional and No-Evidence Summary Judgment---Oral Hearing Requested.
3. **Upon the filing of motion, the clerk must immediately call the motion to the Court's attention.**
4. The Court shall set the motion for written submission or for a hearing 35 days after the date the Motion for Summary Judgment is filed and within:
 - a. 60 days after the motion's filing; or,
 - b. 90 days after the motion's filing:
 - i. If the court's docket so requires;
 - ii. Upon a showing of good cause; or,
 - iii. If the movant consents.
 - c. Any resets must be within the above time frames.
5. **The nonmovant must file any response within 21 days after the motion is filed.**
6. If nonmovant requests an oral hearing, the request must appear in the title of the response.
7. **Movant must file its reply with seven (7) days after the response is filed.**
8. The reply must not raise new summary judgment grounds.
9. **Each party must submit a proposed order before the hearing or written submission date. The proposed order must be filed after the motion or response is filed and separate from the filing of the motion or response.**
10. The Court will record in the docket the date the motion was heard or submitted.
11. The filing of an Amended Motion for Summary Judgment resets all timelines. If an Amended Motion for Summary Judgment is filed, the original Motion for Summary Judgment is automatically denied without prejudice by operation of law according to this Order.
