**STANDING ORDER ON DISCOVERY PRIOR TO A DETERMINATION OF BAIL, PRETRIAL RELEASE, OR ANY CONDITIONS THEREOF**

1. Any information or data which has been or will be provided to any judge for the purpose of assisting the judge in determining bail and any conditions of pre-trial release shall be provided to any attorney representing a criminal defendant prior to said judicial determination. This order includes the defendant's criminal history record information or other involvement with law enforcement agencies, any reports or evaluations concerning physical or mental condition or treatment for any substance use disorder, emergency protective orders, orders of commitment and other such information or data obtained or provided by Travis County officials, agencies, or departments in possession of the information or data. Each official, agency, or department shall establish its own procedures for release of said information or data.
2. Nothing in this standing order prohibits the parties from agreeing to discovery and documentation requirements equal to or greater than those required by this order.
