**District Judges' Order Approving  
Galveston County Auditor's  
Job Classification System and Salary Ranges  
For the Period Beginning October 1, 2022**

On August 11, 2022, the District Judges of Galveston County adopted the Galveston County Auditor's Job Classification System and Salary Ranges for the fiscal year beginning October 1, 2022.

Adoption by the District Judges established the County Auditor Job Classification System and Salary Ranges for assistant auditors, pursuant to Texas Local Government Code §152.011, §152.017, §152.031, §152.905 and §84.021, and further required the County Auditor:

1. To maintain the Job Classification System and Salary Ranges for each position, to be amended as appropriate; the salary range structure to be updated annually for any adjustments, based on market data and inflation, and used for considering assistant auditor salary recommendations during budget deliberations by the District Judges.
2. To establish and maintain appropriate job descriptions in the same manner as the descriptions and format utilized by the Commissioners Court and provide those to the Human Resources Department.
3. To maintain internal procedures for the evaluation of employees and shall use the performance appraisal process to recognize and recommend changes to an employee's compensation during deliberations by the District Judges.

The County Auditor asserts to the District Judges the meeting of the required documentation and provides an updated Job Classification System to account for changes in the market value of the positions of the Office of County Auditor.

**Therefore, be it Ordered** the Job Classification System and Salary Ranges for use in the fiscal year beginning October 1, 2022, and attached hereto, is hereby adopted by a majority vote of the District Judges or by the law.


